There are a number of linguistic organizations that claim they are only cultural organizations even though their membership is mostly Hindu. There is fragmentation not limited just to linguistic line but is deeper within the same linguistic group. For example, create a collaborative platform of Linguistic Organizations to strengthen Hindu society, and stem further fragmentation and exploitation of these communities by political parties and other religious groups. Often inter community conflicts are engineered for various reasons. 	Over the past several centuries, the Hindu Diaspora has spread across the globe forming communities overtime yet there are many unreached areas such as South America, Africa and Eastern Europe. Most of these unreached areas belonged to various indigenous tribes with ancient tradition, culture and heritage. Many of these groups have been either converted to Islam or Christianity. It has been noted that some of these groups continue to practice their ancient traditions although they have been converted. In the present times, there is a revival of these ancient practices and they are looking towards our Hindu community because of similarities. This presents an opportunity which will be further explored in this session with the challenge to develop operational mechanisms and find means to assimilate resources for Hindus to reach these unreached areas.
